 start of the function. The cost of PPL and IPRS License will be borne by the client. In case, the same is to be arranged
 by the hotel, the cost of the same will be charged to the client.
- The use of signage is to be restricted to areas that are provided for the exclusive use of the group, i.e. function areas.

 Prior approval of the hotel management is to be taken before any signage/banner is put up in hotel other than function areas and public places outside the hotel premises (E.g. Directional Signage).
